'Nizam royal family owns ₹439-cr development works to be excluded hectares of land in State'

Representative of legal heirs of Nawab Mir Osman Ali Khan to move SC if land is not returned

Dilshad Jah, the representative of the legal heirs of the last ruling Nizam of Hyderabad Nawab Mir Osman Ali Khan, has claimed that the royal family owns hectares of land all over Maharashtra, including 400 acre land in Aurangabad. Expressing his hope that the State Government will help him get the possession of the royal property, Jah said, "I have full faith in the country's political, judicial and administrative system. In 1950, the Government of India and the last ruling Nizam had signed an agreement to protect movable and immovable property owned by the latter. Referring to which, honourable President of India (PoI) had issued a

letter on July 20, 2016 directing the offices concerned to do justice with the Nizam family. In response to which, the Government of Maharashtra (GoM) through the Department of Forest and Revenue issued a letter to the divisional commissioner on July 7, 2017 directing him to conduct an inquiry and submit a report."

Accordingly, divisional commissioner P N Bhapkar has formed an inquiry committee headed by an additional divisional commissioner. Other key officers on the committee are: district collector, deputy divisional commissioner (revenue), chief executive officer of the Maharashtra State Board of Wakfs, superintendent of land record and Archaeological Survey of India. "I called on Bhapkar on October 27. He assured me of conducting an inquiry. I hope the inquiry will be completed soon and descendants of Nizam get their rightful property," Jah told media persons this afternoon.

It is learnt that there are three legal heirs of the last Nizam—Mukarram Jah (VIII Nizam), his brother Shahamat Jah and sister Fatima Fauzia. "I will move the Supreme Court if the royal property is not returned," Jah said while urging the authorities concerned to take appropriate action by filing FIRs against those who claim to be associates of the royal family. He also expressed his resolve to take Navkhanda Palace and land at Rauza Baugh which is in the possession of a reputed educational institute. "Our property that has been illegally occupied or encroached upon in the connivance of the Maharashtra State Board of Wakfs be freed and necessary legal action taken against guilty," Jah demanded. Jah's lawyer Adv Syed Wajedullah Rashid, retired CEO Saber Khan and others were present at the media briefing.

'Give us our land or pay compensation': Descendants of the last Nizam have been demanding the ownership of important heritage structures, landmark buildings and areas, such as Sunehri Mahal, Navkhanda Palace, District Collectorate, Zilla Parishad office, Labour Colony, Himayat Baugh, Rauza Baugh, Cidco area, Central Bus Stand, Aurangabad Municipal Corporation office, Aam Khas Maidan, Civil Hospital, Government Medical College and Hospital, Police Commissionerate, Divisional Commissionerate, Subhedari Guest House, Haj House, Harsul Jail and Chikhalthana airport. "Give us our land or pay compensation is our demand. If the government is using some of our land for public welfare, we have no objection to it," Jah clarified.

Development works worth Rs 439 crore are likely to be excluded due to cost cutting policies of the government. The government have taken decision to reduce 30 per cent district annual planning grant from various departments in the state thereby affecting entire Marathwada. The experts are raising questions since the GST has improved the earning of the state then why has the government reduced the grant. The District Planning department said that by the end of November, 30 per cent amount was utilized in comparison of Rs 1402 crore and the works of Rs 420 crore will be rejected. the government has decided after less revenue generation. But, some officers said that the government is already increasing much and this decision is not understandable. However, the government have not finalized the department. By the end of October, the State Government has received 40 per cent revenue. Out of tax recovery of

Rs 500 crore, it has generated Rs 131 crore. State president of BJP MP Raosaheb Danve said that it is the decision taken by the government. He cannot say anything on it prior to discussing the same with the CM. The divisional planning committee have said that the follow up to get remaining money is under process.
