Police recover suicide note from victim's house

Aurangabad: The Pundliknagar police on Monday seized a two-page suicide note, which was manually written by deceased stocks trader Jitendra Shah. in which a Cidco N-1-based medico was blamed for his suicide, from his house on Monday. Police inspector Ashok Mudiraj said that Jitendra Shah's brother Rajendra lodged a complaint with the police station squarely blaming the doctor for the suicide. Jitendra, who was a share trader by occupation, had secured ₹2 lakh from the doctor and had repaid ₹2.16 lakh. Nevertheless, the doctor forcibly obtained a cheque of ₹2.53 lakh from him and moreover was threatening him of recovering ₹1,000 daily. Unable to face the brunt, the 49-year-old share trader ended his life on Saturday night.

One killed, two injured as auto turns turtle

Beed: A woman farmer was killed while two others were seriously injured when the autorickshaw they were travelling in, turned turtle at Gade Pimpalgaon in Parli tehsil on Monday morning. According to police, deceased Gokarnabai Rajebhau Gingine (28) along with other women labourers, was going to a farm for plucking cotton. Due to rash driving, the autorickshaw turned turtle in which Gokarnabai Gingine died on the spot. The names of the injured are not available. The police have registered a case of rash and negligent driving with Parli rural police station.

Two labourers found dead

Ahmednagar: Two labourers working with the local coal kiln at Padegaon village in Shrirampur tehsil were found dead on Sunday morning. The police suspect that excessive consumption of alcohol could be the reason for their death. According to details, the owner of the coal kiln found the two victims, Santosh Shiya Waghmare (45) and Ravindra Sakharam Ghogare (28), found lying near the kiln. The two were residents of Roha in Raigad district. The bodies of the victims did not bear any signs of injuries. The police have registered a case of accidental death pending investigations and the medical examination reports.

Activists demand death sentence for rape accused

Beed: The social activists in the town on Monday submit-

ted a memorandum to the district collector demanding fast track trial in rape cases and death sentence to rape accused in cases like Kopardi. As reported earlier, one Shaikh Jawed Saleem, owner of a Mahi Mobile Shopee here has been accused of raping a 15-year-old girl for the last five to six months. The matter came to light now after she became pregnant. The victim is an orphan. Her father died while her mother is visually impaired. Both mother and daughter have been begging in Beed town. 3 farmers end life in four days in Nanded

Nanded, NOV 20: Three farmers committed suicide during the last four days in the district due

to non-production in the agricultural farms. Venkat Giri Naga Gir, a resident of Aural village in Mukhed tehsil, committed suicide for continuous non production and overburden of debt, on evening of Sunday by hanging himself to a tree. He had 8-acre land with cultivation of soyabean, moong, udat and cotton. But he lost most of the crops due to infestation of pests. Not able to bear the loss he committed suicide. The Mukramabad police filed a case of accidental death. The deceased is survived by a son and four

In another incident, a debt-ridden farmer identified as Antara Ganpati Boinwad (32), resident of Pandurni village in Bhokar tehsil, committed suicide by jumping into the lake in the Bhokar tehsil. He could not repay the debts of Rs 50,000 to the SBI due to non-production in his agricultural farm. The dead body was recovered late evening. On the basis of a complaint lodged by Maruti Boinwad, the Bhokar police filed a case of accidental death.

In a third incident, a farmer Ganesh Nagorao Farkande, a resident of Pangari village in Kinwat tehsil committed suicide by consuming poison and later on jumping into a well on November 16.

The reason was the harassment caused by the private money-lenders from whom he had borrowed Rs 5 lakh. The deceased got a loan from the private money lenders by mortgaging his agricultural land. The money-lenders harassed him for repayment of the loan. For not bearing it, Farkande took the extreme step.

As per the complaint lodged by his wife Lakshmibai, the Islapur police filed a case against the money lenders Balaji Raghunath Kadam and Pandit Raghunath Kadam under various sections of the Indian Penal Code. The assistant police inspector Rameshwar Kayande is investigating the matter.

Man stoned to death at Nitrud

In a sensational incident, a 40-year-old man was stoned to death over sharing of water from a common tubewell on Majaglaon- Telgaon road at Nitrud in Majaglaon tehsil on Monday.

According to reports, there is a common tube-well to be shared among Bhagawat Banurao Gayake (deceased) and four others - Dinkar Dake, Bandu Dake, Shiva Dake and Datta Dake in Nitrud Shivar.

Kaushalya, the mother of the deceased, lodged a complaint of murder murder against the Dake brothers with Dindrood police station. The murder took place over the distribution of the tubewell water. On Monday morning, when deceased Bhagwat Gayake went to start the tubewell, accused Dinkar Dake, Bandu Dake, Shiva Dake and Datta Dake opposed him from starting the tubewell. So, the verbal exchange between them turned to blowing. The deceased was about to run away from the spot when the four accused followed him and hit him with stones on his head. Gayake died on the spot due to excessive bleeding as well as brain haemorrhage.

The police reached the spot and sent Gayake's body for post-mortem to Majaglaon rural hospital. The police have arrested Dinkar Dake and the other accused absconding.

Motorcycle, phone stolen

Aurangabad, Nov 20: A motorcycle and a mobile handset totally phone Rs 52,000 were worth reported stolen to the police stations concerned by their respective owners on Sunday. According to

Osmanpura police, Kachrulal Chandulal Saboo (65, Jyotinagar), a pensioner, complained to the police station that he dropped his grandson at his home after parking his motorcycle (MH-20-EM-6279) with its key in the keyhole of the dickey in front of Shrirang Vila at 1.40 pm on Saturday. He was shocked not to find the motorcycle where he had parked it minutes back. Somebody took the key out of the dickey, started its engine and fled the spot in a trice. Based on his complaint, a theft case has been registered in the police station. 
Bali, recently. This RRC was addressed
